Background

This meeting to be held in Lima, Peru will be the second formal meeting of the interdisciplinary Expert Group organized by the TRANSfer project on Transport and Climate Finance.

The TRANSfer project is run by GIZ and funded by the International Climate Initiative of the German Ministry for the Environment, Nature Conservation, Building and Nuclear Safety (BMUB). Its objective is to support developing countries to develop and implement climate change mitigation strategies in the transport sector as „Nationally Appropriate Mitigation Actions“ (NAMAs) (www.transport-namas.org). At international level and closely linked to the UNFCCC process, the project helps accelerate the learning process on transport NAMAs. Therefore the TRANSfer project has initiated activities to promote the uptake of the use of climate finance in sustainable transport. In this context it is facilitating a group of transport finance and climate finance experts to develop recommendations for the effective and efficient use of climate finance in the transport sector.

It is expected that the Expert Group will be active from July 2014 for a period of approximately 1,5 to 2 years. Please find more information on the group at: <http://transport-namas.org/expertgroup/expert-group-on-climate-finance-for-sustainable-transport/>

Scope and objectives

The Lima meeting is an important milestone on the road to COP 21 in December 2015 in Paris, France. The meeting will (a) review activities carried out under the auspices of the Expert Group since the inaugural meeting in Manila, Philippines in September 2014 (see <http://transport-namas.org/wp-content/uploads/2014/09/TRANSfer-Manila-Workshop-Report.pdf> for a report on the Manila meeting), and (b) discuss next steps for the Expert Group in 2015. The review of past and ongoing activities will focus on discussing two reports in progress that will be presented in Lima. This includes the report “Shaping the role of climate finance for sustainable transport”, which on the basis of a number of case studies makes recommendations on how Climate Finance can function as a lever for realizing low carbon transport. The second is a document targeted at policy makers on transport and climate finance, which considers the desired relationship between climate finance and other sources of funding for sustainable, low-carbon transport.
